<p>Coordination with local public health authority(ies) including Tribal health departments</p>	<p>The principal will coordinate with the ODE and OHA guidelines. It will be the principal's responsibility to train and enforce the guidelines at the building level.</p> <p>Visitors and families will be required to wear masks while in the school building. Volunteers in the building, will be required to be fully vaccinated.</p> <p>Parents will be informed of expectations at Back to School events, in this document on the website and in reminders in the weekly newsletter.</p> <p>Students will be trained on procedures during the first weeks of school and then ongoing as needed.</p>

COVID-19 vaccinations to educators, other staff, and students if eligible	All staff will show proof of vaccination by October 18th. Mandates will be followed in accordance with state law.
Universal and correct wearing of face coverings	All people in the school buildings will wear a correct fitting mask at all times. Verified medical exemptions will be honored

<p><u>Ventilation and air flow</u></p>	<p>When the heat is off, there will be a fan exhausting air from the rooms through windows and another fan blowing in outside air.</p> <p>When the heat is on, the system pulls in outside air so, only the exhaust fan will be running.</p> <p>Each room is also outfitted with HEPA filters which will be running during school and childcare hours.</p>
<p><u>Handwashing and respiratory etiquette</u></p>	<p>Handwashing will happen at the following times during a school day: Arrival, return from recess or PE, before and after lunch and snacks, after using the bathroom</p> <p>It will also happen when a child is seen blowing their nose or touching their face.</p> <p>There is also hand sanitizer in all classrooms and common spaces for students to use between sink washing.</p>

<p>Cleaning Protocols</p>	<p>Increased schooltime hours for custodial staff to allow for: daily disinfecting of tables and high touch surfaces cleaning of the bathrooms at mid-day and end of day all other regular cleaning will also occur Learning tools will be kept student specific as much as possible. Shared tools and toys will be disinfected daily.</p>

<p>Free, on-site COVID-19 diagnostic testing</p>	<p>Covid-19 testing materials are available at school. They will be used when the LHA advises administration to do so.</p>
<p>Public health communication</p>	<p>The LHA, OHA and the Archdioceses DCS will be notified if a positive case of Covid is discovered in the school community. ReadySchoolsReentry@co.marion.or.us would be our initial point of contact The principal fills out the weekly report to the Archdiocese/ODE/OHA, reporting weekly numbers and attendance</p>

<p><u>Isolation:</u> Health care and a designated space that is appropriately supervised and adequately equipped for providing first aid and isolating the sick or injured child are required by OAR 581-022-2220.</p>	<p>If a child is showing symptoms of Covid-19, they will be isolated in the room labeled “isolation” behind the school office. If a staff member is showing symptoms, they will be sent home immediately. If it is a student, they will be isolated and parents will be called to pick them up as soon as possible.</p> <p>Symptoms include: fever, cough, chills, shortness of breath, loss of taste/smell, and also common cold symptoms. Therefore, if your child has the above or any other symptoms such as: headache, sore throat, or runny nose you should keep them home until further discussion with their primary care physician.</p>

<p><u>Exclusion:</u> School administrators are required to exclude staff and students from school whom they have reason to suspect have been exposed to</p>	<p>Staff and families will be expected to report exposure and exclude themselves. If needed, the administration will impose the exclusion.</p> <p>“Exposure” is defined as spending more than 15 minutes with a person closer than 6 feet without a mask, or closer than 3 feet with a mask.</p> <p>If a staff/student tests positive:</p> <ul style="list-style-type: none"> *The person isolates at home for up to 10 days after the onset of symptoms and after 24 hours of no fever without medication and reduction of symptoms *In a classroom where correct mask usage and 3 feet distancing are consistent, other students and staff will be allowed to continue to come to class

<p>COVID-19. (OAR 333-019-0010)</p>	<p>*In a classroom where either rule was not determined, LPHA will determine whether to isolate the entire class or just certain members</p> <p>*All families of the infected person’s cohort will be informed by email fo the potential risk and instructed on next steps</p> <p>If a vaccinated staff member is exposed to someone who tests positive, and they are symptom free, they will continue to teach. If an unvaccinated member of staff is exposed, they will be quarantined for 10-14 days . All staff will be fully vaccinated by October 18th or have an approved medical exception on file.</p> <p>If a staff or student has a household member who tests positive for Covid-19 and they’re vaccinated, they do not need to quarantine. If they are not vaccinated, they quarantine for 14 days from the date of the family member’s onset of symptoms.</p>
